C. <u>Circuit Planner and Engineer - Update on Current Tasks (Braden Duran) [INFORMATION]</u>

Summary: This is an update on those tasks underway through Fresno COG's Circuit Planner and Engineer Program, which provides technical assistance to the small cities in Fresno County. Such assistance may include, but is not limited to: planning studies, delivering projects, grant applications, environmental documents, engineering services, etc.

Circuit Planning & Engineering

 Reedley Manning/Buttonwillow Master Plan Assistance – Rincon and VSCE met with the City of Reedley staff to develop the project site plan. Staff discussed City needs and opportunities with the project site, including incorporating the Reedley Trail, which supports Blueprint principals to improve active transportation. VSCE has prepared a draft site plan and with Rincon are developing draft concepts.

Consultants are reaching out to additional cities on potential projects previously identified.

Circuit Planning

- Coalinga Rincon completed the request for proposals for Coalinga Trails CEQA/NEPA analysis, and the City released the RFP in April.
- Sanger zoning review Collins & Schoettler have completed Sanger's zoning review and have submitted the report to the City of Sanger and Fresno COG.

Circuit Engineering

Conducting the active transportation counts listed below have been put on hold during the COVID-19 pandemic. The cities have requested this as the traffic counts will not reflect normal conditions during this time.

- Fowler VSCE is developing a plan for conducting Active Transportation Program (bike/ped) counts
- Mendota VSCE is developing a plan for conducting Active Transportation Program (bike/ped)
- Firebaugh VSCE continues to coordinate with staff on potential projects.

Fresno COG and the Circuit Planning & Engineering team are reaching back out to the cities and exploring additional opportunities to assist these cities in light of the above work being put on hold.

E. <u>Notice of Funding Availability Transit-Oriented Development Housing Program Round 4 (Trai Her-Cole) [INFORMATION]</u>

Summary: The California Department of Housing and Community Development (HCD) has announce the release of the Round 4 Transit-Oriented Development (TOD) Housing Program final guidelines and Notice of Funding Availability for approx. \$141 million. The primary goal of the Transit-Oriented Development Housing Program is to promote the use of public transit and to stimulate affordable housing developments near transit stations. Under the program, low-interest loans are available as gap financing for rental housing developments that include affordable units. Grants are available to cities, counties, and transit agencies for infrastructure improvements necessary for the development of specified housing developments or to facilitate connections between these developments and the transit station.

Applications are due by July 30, 2020 at 5:00 p.m.

A. Obligational Authority and Project Delivery Update (Jennifer Soliz) [INFORMATION]

Summary: On April 1, 2020, Fresno COG staff submitted the federal fiscal year (FFY) 2019/20 Obligation Plan to Caltrans's Division of Local Assistance. This plan documents Fresno COG's estimated project delivery for the remainder of 2019/20. The obligational authority (OA) target for 2019/20 is \$27,758,441.

As of March 31, 2020, only \$7,418,221 or 26.7 percent of federal Congestion Mitigation Air Quality (CMAQ) program and Surface Transportation Block Grant (STBG) funding had been obligated, leaving our region with an estimated OA balance of \$20,340,220. The obligation plan outlines approximately \$18 million in additional, combined CMAQ and STBG, which is still short of the remaining OA target.

In April, COG staff met with all local agencies to discuss their obligation plans and any changes to

programmed projects. Approximately \$3.9 million in projects will be delayed, and another \$2.5 million were expedited to offset those delays. These changes are reflected on the quarterly report attached. In January, staff reviewed the 2019/20 OA plan and determined the region was on track to exceed its OA target by 1 percent. With the delays and other changes, staff is now projecting a delivery rate of 93.9 percent.

The FFY ends September 30, 2020; however, as of May 1, the federal funds become available to the rest of the state on a first-come, first-served basis. Per Caltrans HQ and Local Assistance, the state is anticipating OA will be exhausted by mid-May. This is much earlier than we have seen in previous years, and projects not submitted to Caltrans for authorization by May 1 are at risk of being delayed.

It is the state's goal to exceed the OA target and, in August, receive additional federal funds redistributed from other states to projects pending authorization. We encourage all agencies to submit their Requests for Authorization as soon as possible to get in the queue for the funds that will become available. If projects do not receive authorization approval after August, they will be delayed to October 2020, the next federal fiscal year.

B. <u>Regional Transportation Plan Roundtable Public-At-Large Applicant Selection (Brenda Veenendaal) [APPROVE]</u>

Summary: Fresno COG's Policy Board approved its 2022 Regional Transportation Plan (RTP) Roundtable positions in February 2020 with the caveat that all public-at-large applications be screened by COG staff, appointment recommendations be forwarded to the TTC and PAC for review and recommendation, and the Policy Board grant final approval at its May meeting. The first Roundtable meeting is scheduled for 2 p.m. on June 24.

The Roundtable supports Fresno COG staff and COG standing committees in developing the 2022 RTP and Sustainable Communities Strategy (SCS). It is vital to the process that the Roundtable generates consensus about the plans, based upon the input of an informed and active local constituency. While the Roundtable will provide comments and input on issues related to the 2022 RTP/SCS, the final decisions on RTP content will be the Policy Board's responsibility.

COG staff released the RTP Roundtable application on March 3, 2020, for those positions that are not appointed by a local or public agency. Three public-at-large applications were received for review and approval, and have been attached. The applicants are:

- Gail Miller, retired, Caltrans
- Jim Hunter, Senior Managing Consultant (semi-retired) for Knowledge Solutions Group
- Sal Petrucelli, retired, Longs Drugs/CVS Pharmacy management (application to follow)

C. FINAL 2020-21 Overall Work Program and Budget (Robert Phipps) [APPROVE]

Summary: The fiscal year (FY) 2020-21 Overall Work Program (OWP), totaling \$21,737,779, is submitted for approval. The proposed budget increased \$1,524,545 from last year.

Federal revenues decreased 19 percent (\$1,137,460). FTA 5304 decreased \$269,372, reflecting progress on the Better Blackstone Challenge. Projects funded by FTA Section 5310 Enhanced Mobility of Seniors & Individuals with Disabilities program decreased \$494,705 reflecting programmed bus procurements for transit agencies while FTA Section 5316 & FTA Section 5317 were reduced by \$156,281 as grants funded by the discontinued JARC and New Freedom program are closed out. Federal planning funds decreased \$349,461 as carryover FHWA PL and FTA 5303 balances are spent

down.

State revenues increased 257 percent (\$4,588,834). The largest portion of this increase centers around the State Regional Early Action Planning Program (REAP) which provides \$4,749,860 to Fresno and Central Valley MPOs to develop a Valleywide plan for housing. Also, STIP planning funds (\$399,000) were reinstated in the 2018 STIP to fund FCOG's stewardship of the multi-million dollar federal aid projects allocated to local agencies in Fresno County. State Highway account, SPR, and RMRA funding all decreased a total of \$569,421, reflecting progress on programmed projects.

Local revenues decreased 15 percent (\$1,834,556), reflecting drawdowns on Measure C funded projects such as the significant design phase of the Golden State corridor, Fresno State Transportation Institute, and FCRTA electric vehicle purchases.

Staff activity surrounding the Measure C III reauthorization will also be a major initiative for 2020-21.

Staffing & Benefits:

There are no new Fresno COG planning positions included in this year's proposed budget. FCRTA reclassified an Administrative Assistant position to Operations Manager and added an accounting position. Contingencies are carried for merit-based salary increases as well as contingencies for anticipated health insurance increases. The overall proposed budget for salaries increased by 8 percent and benefits by 11 percent.

Overhead Accounts:

Overhead accounts increased by 4 percent (\$18,793 total) reflecting increases in computer supplies (\$5,000), building maintenance (\$1,000), and travel (\$11,500). The office lease also was adjusted up \$8,937 per the existing contract. Another \$7,644 in audit expenses were reallocated to a direct program.

Consulting:

The overall consulting budget is \$4.8 million, which is a decrease of \$744,846 corresponding to projects associated with revenue reductions discussed above regarding multi-year projects. Some of those include the Eastside Corridor Study and the Fresno-Madera Sustainable Corridor Study along State Route 41.

After an opportunity for public comment, Mr. Stites (FCRTA) motioned and Ms. Hansaker (Chamber) seconded to approve the consent agenda as presented. The motion passed.

TRANSPORTATION ACTION/DISCUSSION ITEMS

A. Fresno County Transportation Network Vulnerability Assessment Final Report (Kristine Cai) [ACCEPT]

Ms. Cai (FCOG) reported that Fresno COG received grant funding from Caltrans under the Senate Bill (SB) 1 Adaptation Planning Grants Program to conduct a Transportation Network Vulnerability Assessment (TNVA) for Fresno County. The TNVA aimed to assist Fresno COG and its member agencies in understanding and adapting to the potential impacts of climate change on the region's transportation infrastructure. The study's major work products included a public outreach plan and synopsis, a vulnerability assessment report, and an adaptation strategies report.

The TNVA found that much of the Fresno region's transportation system and its users are likely to be affected by changing climate conditions. Primary climate-related hazards affecting transportation include: flooding, wildfire, extreme temperatures, and precipitation-induced landslides.

One of the analysis' major components was a risk indicator scoring process that combined relevant data on climate hazards and assets into vulnerability scores representing the relative risks facing different assets. This systemwide process helps identify the most vulnerable assets, which should be assessed at the project level.

The TNVA also identified potential adaptation strategies that can be implemented around the county to prepare for climate change impacts. The resulting list of strategies is intended to act as a menu of various response options, which Fresno COG and its stakeholders can pull from as needed. There are a wide range of responses to consider, including changes to planning, policy, design, operations, and maintenance.

This information can inform the next Regional Transportation Plan/Sustainable Communities Strategy (RTP/SCS) update and also help local jurisdictions meet the SB 379 requirements, which mandate that all cities and counties address climate adaptation and resiliency strategies in the next revision of their general plans' safety elements.

After an opportunity for public comment, Mr. Mozier (Fresno City) motioned and Ms. Sumner (Fresno Cycling Club) seconded to recommend that the Policy Board accept the Fresno County Transportation Network Vulnerability Assessment Final Report. The motion passed

B. 2021 Regional Active Transportation Program (ATP) Cycle 5 Guidelines, Resolution 2020-11 (Jennifer Soliz) [APPROVE]

Ms. Soliz (FCOG) reported that the State established the Active Transportation Program (ATP) in September 2013. ATP funding is distributed as follows:

- Fifty percent to the State for a statewide competitive program ("Statewide Competitive ATP");
- Ten percent to the small urban and rural area competitive program, managed by the State; and
- Forty percent to the large urbanized area competitive program, with funding distributed by population and managed by the Metropolitan Planning Organization ("Regional ATP").

Fresno COG is responsible for developing guidelines for the regional ATP and for recommending projects to the California Transportation Commission. The Regional ATP Guidelines substantially follow those of the CTC but include some differences based on the region's priorities. Fresno COG developed the guidelines in consultation with Fresno COG's ATP Multidisciplinary Advisory Group (MAG), which includes representatives from Caltrans, other government agencies, and active transportation stakeholder organizations with expertise in public health and pedestrian and bicycle issues, including Safe Routes to School programs. The California Transportation Commission (CTC) is scheduled to approve the guidelines at its May meeting.

The California Transportation Commission (CTC) adopted final 2021 ATP Guidelines on March 25, 2020. There were changes at the statewide level from Cycle 4 to Cycle 5, including new and revised language in categories such as project/program amendments (scope changes), performance metrics, scoring criteria and timely use of funds. Considerable program changes include:

- Updated Disadvantaged Communities criteria to include a Healthy Places Index
- An updated project size threshold for small and medium infrastructure/non-infrastructure projects
- Eligible projects quick-build project pilot program

The MAG agreed that the regional guidelines and criteria should match the adopted statewide guidelines as closely as possible. Only a few minor differences remain between the statewide guidelines and Fresno COG's regional guidelines. As in previous cycles, the MAG agreed to continue with no minimum funding award and to encourage funding awards of \$2 million or less per project. Fresno COG will hold a separate call for projects for the Regional ATP and have a regional scoring committee. Applicants may apply for either the State ATP program or Regional ATP program, or both. Fresno COG encourages all ATP projects to be submitted to the State ATP competitive program, although it is not required. Projects not selected for programming in the statewide competition must be considered in the regional competition.

The statewide competitive call for projects is now open, and applications will be due to Caltrans on June 15, 2020. Once CTC approves the Regional ATP Guidelines (May 15-16, 2020), the regional call for projects will open, with applications due August 14, 2020.

The MAG and staff recommend several changes that have been identified in the guidelines, shown in red. These changes are consistent with the statewide guidelines.

After an opportunity for public comment, Mr. Stites (FCRTA) motioned and Ms. Morales (Reedley) seconded to recommend the Policy Board approve Resolution 2020-11 adopting the Fresno COG Regional Competitive Active Transportation Program Guidelines and accept the Multidisciplinary Advisory Group list. The motion passed.

C. Release of Measure C New Technology Reserve Program 2018 Grant Application (Peggy Arnest) [INFORMATION]

Ms. Arnest (FCOG) reported that Fresno COG is seeking proposals from eligible public agencies for advanced transit and transportation projects that have the potential for broad benefits to Fresno County residents and will assist the region in meeting its air quality goals. Fresno COG and the Fresno County Transportation Authority (FCTA) are proposing to fund projects of regional significance in the areas of research, development, demonstration, and deployment that will advance public transit and transportation. This third cycle of the Measure "C" New Technology Reserve Program will make approximately \$5.4 million available for eligible new technology projects/programs. The 2020 application is attached to this item.

In February 2016, the Policy Board approved a formal process to solicit and accept members to sit on a Multidisciplinary Advisory Group (MAG). The MAG will review, evaluate and score the New Tech applications and recommend projects for funding. Nominees are needed from the following: City of Fresno, City of Clovis, east side city, west side city, County of Fresno, Measure C Citizens Oversight Committee, FCTA, transit, business, education and two public seats. The MAG application will be released in the early summer.
